## Section 04 First-Aid Measures

### Description of necessary first-aid measures

- Inhalation** Eliminate all ignition sources if safe to do so. Remove source of exposure or move person to fresh air and keep comfortable for breathing. Call a POISON CENTER or doctor if you feel unwell.
- Ingestion** Rinse mouth. Get medical advice / attention if you feel unwell or are concerned.

<b>Skin contact</b>	Avoid direct contact. Wear chemical protective clothing, if necessary. Take off immediately contaminated clothing, shoes and leather goods. Rinse skin with lukewarm, gently flowing water / shower for 15 to 20 minutes. Store contaminated clothing under water and wash before re-use or discard. Get medical advice / attention. Wash contaminated clothing before re-use, or discard.
<b>Eye contact</b>	Remove source of exposure or move person to fresh air. Rinse eyes cautiously with lukewarm, gently flowing water for several minutes, while holding the eyelids open. Remove contact lenses, if present and easy to do. Continue rinsing for 30 minutes. Take care not to rinse contaminated water into the unaffected eye or onto the face. Immediately call a POISON CENTER or doctor.

## **Section 05 Fire Fighting Measures**
