## Section 04 First-Aid Measures

---

### Description of necessary first-aid measures

- Inhalation** Remove source of exposure or move person to fresh air and keep comfortable for breathing. Call a POISON CENTER or doctor. If breathing has stopped, trained personnel should begin rescue breathing or if the heart has stopped, immediately start cardiopulmonary resuscitation (CPR) or automated external defibrillation (AED). Avoid mouth to mouth contact by using a barrier device.
- Ingestion** Rinse mouth. Do NOT induce vomiting. Immediately call a POISON CENTER or doctor. If vomiting occurs naturally, lie on your side, in the recovery position.
- Skin contact** Avoid direct contact. Wear chemical protective clothing, if necessary. Take off immediately contaminated clothing, shoes and leather goods. Rinse skin with lukewarm, gently flowing water / shower for 30 minutes. Store contaminated clothing under water and wash before re-use or discard. Immediately call a POISON CENTER or doctor. Wash contaminated clothing before re-use, or discard.
- Eye contact** Avoid direct contact. Wear chemical protective gloves, if necessary. Remove source of exposure or move person to fresh air. Rinse eyes cautiously with lukewarm, gently flowing water for several minutes, while holding the eyelids open. Remove contact lenses, if present and easy to do. Continue rinsing for 30 minutes. Take care not to rinse contaminated water into the unaffected eye or onto the face. Immediately call a POISON CENTER or doctor.

### Most important symptoms and effects, both acute and delayed

- Inhalation** Causes severe burns to the mouth and throat (mist). Harmful if inhaled. May cause respiratory irritation.
- Ingestion** Causes burns to the mouth and throat.
- Skin contact** Causes severe skin burns.
- Eye contact** Causes serious eye damage.

## Section 05 Fire Fighting Measures

---

- Suitable extinguishing media** This material is an oxidizer. Use large quantities of water as fog to fight fires in which this material is involved.
- Unsuitable extinguishing media** Carbon dioxide or other extinguishing agents that smother flames are not effective in fires involving oxidizers. Do NOT use dry chemical fire extinguishing agents containing ammonium compounds (such as some A:B:C agents), since an explosive compound can be formed. Water jets are not recommended in fires involving chemicals.
- Specific hazards arising from the chemical** May intensify fire; oxidizer.
- Special protective equipment for fire-fighters** Wear NIOSH-approved self-contained breathing apparatus and chemical-protective clothing.

## Section 06 Accidental Release Measures

---

- Personal Precautions / Protective Equipment / Emergency Procedures** Wear appropriate personal protective equipment (See Section 08 Exposure Controls and Personal Protection). Keep away from heat, hot surfaces, sparks, open flames and other ignition sources. No smoking. Keep away from clothing and other combustible materials. Stay upwind, ventilate area. Do not breathe vapours, fumes, or mists. Do not use material handling equipment with exposed metal surfaces.
- Environmental Precautions** Prevent material from entering waterways, sewers or confined spaces. Notify local health and wildlife officials. Notify operators of nearby water intakes.

## Methods and Materials for Containment and Cleaning Up

SMALL SPILLS: Stop or reduce leak if safe to do so. Clean up spill with non-reactive absorbent and place in suitable, covered, labeled containers. Flush area with water. Contaminated absorbent material may pose the same hazards as the spilled product. Use vented containers to avoid pressure buildup.  
LARGE SPILLS: Contact fire and emergency services and supplier for advice.

## Section 07 Handling and Storage

- Precautions for Safe Handling** Use proper equipment for lifting and transporting all containers. Use sensible industrial hygiene and housekeeping practices. Wash thoroughly after handling. Avoid all situations that could lead to harmful exposure. Prevent the release of vapours, fumes, or mists into the workplace air.  
Inspect containers for damage or leaks before handling. If the original label is damaged or missing replace with a workplace label. Have suitable emergency equipment for fires, spills and leaks readily available.  
Never return contaminated material to its original container.
- Conditions for Safe Storage** Store in a cool, dry, well-ventilated area, away from heat sources and incompatible materials. Always store in original labeled container. Keep containers tightly closed when not in use and when empty. Empty containers may contain hazardous residues. Protect label and keep it visible. Do not transfer to metal containers.

Organic material, such as wood, paper, gasoline, diesel, solvents and some glycol based heat transfer fluids

### Engineering controls

- Ventilation Requirements** Mechanical ventilation (dilution or local exhaust), process or personnel enclosure and control of process conditions should be provided in accordance with all fire codes and regulatory requirements. Supply sufficient replacement air to make up for air removed by exhaust systems.
- Other** An emergency shower and eyewash station should be available, tested, and be in close proximity to the product being handled in accordance with provincial regulations.

### Protective equipment

The following are recommendations only. Exposure to hydrogen peroxide also increased the toxicity of ozone in animals.
